

The Declaration of Constitutional Compliance

That whenever a people find its governance replete with nefarious political agenda, influence and usurpation, it is their right and it is their duty, to resolve such nefarious intent by asserting their supreme authority over that governance.

We The People, in the 1st quarter of the 21st century, found that our governance was indeed replete with such nefarious intent; -- **Therefore**, in resolution of such, *We The People* shall reinstitute the founders' fundamental **Founding Principle** of the supremacy of the individual USA citizen wherein each and every citizen is equal [*under governance*] and sovereign and are endowed, through nature's creation, with unalienable rights and are guaranteed their responsible-pursuit¹ of happiness as each are able and so chooses without interference or intervention or surrogacy of others or government.

We The People's Authority: **The unanimous Declaration of the thirteen united States of America**

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. That to secure these rights, Governments are instituted among Men, deriving their just Powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. • • • But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and provide new Guards for their future security.

We The People observed, in the 1st quarter of the 21st century, that our governance design was that of pursuing absolute Despotism over *The People* wherein it is *The People's right and duty* to arrest such design and provide **astute** Guard in securing *The People's* future with enumerated principle, oversight and power effecting *The People's Liberty, Safety and Happiness*.

We The People are **painfully aware** that when government grows tyrannical, increasingly governs without our consent and does not responsibly or objectively monitor its own constitutional compliance it prompts *The People* to establish **astute** oversight in monitoring government at the federal, state and lower levels and command their absolute constitutional compliance.

Constitutional Compliance shall be...

We The People, therefore, solemnly publish and declare, That *We The People* shall **astutely** further the enumeration of our Constitution in such manner **compelling** constitutional compliance to secure and preserve the founders' fundamental **Founding Principle** thus ensuring *The People's Liberty, Safety and Happiness*.

Treason for Noncompliance...

We The People declare that intentional allowance of any unconstitutional aspects² of government is treasonous and strictly prohibited and require the immediate removal of all government members authorizing or perpetrating or participating or who promote or promulgate or condone or, upon knowledge of such non compliance, fail to immediately and publicly and widely disclose any and all such non compliance or in failing to act upon knowledge of such non compliance to vigorously defend against it. All of any such complicity shall be prosecuted for treason.
